Better Chicken Commitment - Loungers Annual Progress Report - July 2024

Loungers is committed to improving chicken welfare standards and is working towards meeting the Better Chicken Commitment for 100% of the chicken in our supply chain by 2026.

The table below shows our current compliance versus BCC criteria.

Commentary

Our two primary chicken suppliers remain committed to meeting the BCC criteria by 2026. We are challenging them to improve on their metrics for 24/25 and continue to explore our options. Our supplier of chicken fillet now has a dedicated poultry buyer who is working with their farmer suppliers to raise standards. It has made good progress on environment with further improvements to come this year. We also expect to see further progress in stocking density with both suppliers. We support the call for a ban on the use of water bath stunning and have requested that our chicken fillet supplier adopts controlled atmospheric stunning.

We recognise that slower growing breeds have better welfare outcomes but this continues to be a challenge as neither of our principle suppliers currently farm them. We have requested that they begin supplying us chicken from these breeds and are also exploring direct supply to challenge this.

The remaining 2% of the volume of chicken we procure is in chicken strips. We have communicated to our supplier that we are committed to meeting the BCC criteria by 2026. We are awaiting their compliance report.
